## 4. Developing a County Broadband Strategy

County Economic Development staff will be working with the Senior Leadership Team and will begin developing a framework for a County Broadband Strategy under the Modernization Program (if approved). The goal is to ensure the County is positioned to optimize broadband service delivery across the County as rapidly and cost-effectively as possible. A Broadband Strategy will ensure the County is fully prepared to pursue and respond to broadband investment and funding opportunities, and to have full knowledge of the capabilities and areas of interest of our local Internet Service Providers.

Components of the strategy will include:

- Examination of County owned assets that we could lease to proponents.
- Coordination of fibre conduit in road infrastructure when built.
- Coordination of local Internet Service Providers (ISPs) to identify and exploit efficiencies and collaboration.
- Strengthening relationships with major cable, telecom and satellite broadband service providers.
- Coordinating the needs and opportunities emerging from our major institutions, employers, new business, and residential developments in order to identify business opportunities that will encourage all ISPs to extend coverage in the County.
- Develop a living document Business Case for broadband service in the County to be provided to all ISP providers and upper tier governments.

# 8. Shop the Valley and New Business Spotlight Social Media Campaign Results

Economic Development delivered Shop the Valley, a campaign via print, radio and social media from November to the first week of January to promote local shopping. In January Shop the Valley was followed up with a complementary campaign to promote new local businesses directly raising awareness and encouraging shopping from local businesses by specifically profiling them on social media platforms. Results from the social media metrics are below. These clearly show that the level of interest in local Christmas shopping options, and then interest in learning about new local businesses was very high and the social media information shared enabled and encouraged people to investigate and learn more about them.

- Social Media Impressions: 42,619 (increase of 165% compared to previous 60 days) – Number of times content was displayed to users.
- Engagement: 3,763 (increase of 115% compared to previous 60 days) Number of times users engaged in posts.

- Link Clicks: 445 (up 411% Compared to previous 60 days) Number of times users clicked on links in posts, indicating they were seeking more information and direct contact with the business.
- Followers Gained: 67 (up 267% compared to previous 60 days).

## 1. Ottawa Valley Women's Collective

<u>Local Tourism Marketing respecting COVID-19 Precautions – Profiling</u> Women Leaders in the Tourism Sector

The Ottawa Valley Tourist Association (OVTA), in partnership with Enterprise Renfrew County, Your Ottawa Valley TV and myFM Radio are working with Holly Molenaar of OV Boss Babes to host the first *Ottawa Valley Women's Collective* in support of International Women's Day on March 8, 2021.

The "Ottawa Valley Women's Collective" is a podcast series that recognizes 12 influential and entrepreneurial female leaders from across Renfrew County. The women represent a variety of sectors and businesses, including tourism, retail, not-for-profit and community awareness. Each woman will be sharing how they #choosetochallenge (International Women's Day theme) through raising awareness against bias and taking action for equality.

Each week, leading up to March 8, 2021, OV Boss Babes will announce two women from the Collective and how they are making a difference through community building, women empowerment, business awareness and volunteerism. On March 8, a special two-hour podcast featuring the 12 women will be released, as well as a one-hour TV episode on YourTV.

The OV Boss Babes podcast is available on Spotify and Apple.

## 2. Winter Photo/Video Shoots

Winter photo and video shoots are planned for February and March in partnership with various municipalities. The purpose of the photo and video shoots are to gather updated digital assets that can be used for tourism and recreational promotion by the Ottawa Valley Tourist Association, municipal and tourism partners. ## 3. Recent Tourism Funding & Support Programs

The <u>TRIP Capital Funding Program</u>, announced by the Ontario's Highlands Tourism Organization in January, is now fully subscribed. This program supports Small and Medium Enterprises (SME) with up to \$20,000 in a non-repayable grant, whereby the applicant is responsible for 20% of total project costs. Funding is to support eligible capital investments related to COVID-19, including re-configuration of spaces, purchase of personal protective equipment (PPE), digitization of experiences, including virtual ticketing, e-commerce, etc.

A webinar with the Honourable Lisa MacLeod, Minister of Heritage, Sport, Tourism and Culture Industries and government representatives was held on February 4, 2021 to review the various funding and support programs currently available from the Ontario Government. The webinar was open to all tourism operators, not-for-profits and community organizations from across the Ontario's Highlands region.

## 4. OVTA Detailed Draft 2021 Budget

The draft 2021 budget, submitted to the OVTA Board at the November 18, 2020 meeting has been approved. As per the annual approval process, the draft budget will be presented to the City of Pembroke during the OVTA's annual presentation to their Council on March 16, 2021. Once approved by

City Council, the budget will be presented to County Council for final review and approval.

### 5. **OVTA Tourism Awards**

The 2021 OVTA Tourism Awards presentation will resume its normal schedule of presentation at the Annual General Meeting at the end of April (date to be confirmed). Awards are for merit and events taking place in 2020 and will be launched on March 1, 2021 in three categories:

- Marilyn Alexander Tourism Champion Award for an individual.
- Business of Distinction Award for a deserving business.
- Special Event of the Year for an in-person or virtual event.

## 1. Ontario Together Fund

Attached as Appendix ERC-I is a letter to Ms. Colleen Sadler, Enterprise Renfrew County from MPP John Yakabuski. In the letter, MPP Yakabuski offers congratulations to the Enterprise Renfrew County (ERC), as an Ontario Small Business Enterprise Centre (SBEC), for receiving a portion of the Ontario Together Fund to support our provision of small business advice and information during the COVID-19 pandemic.

## 2. Ontario Small Business Support Grant

Attached as Appendix ERC-II is information with regards to the Ontario Small Business Support Grant that is now open through the Province. This grant is to assist businesses with additional costs incurred with the COVID-19 safety measures that have been implemented due to provincial public health requirements.

# 3. County of Renfrew COVID-19 Business Development Fund Final Reports from Recipients

The final reports from the 74 businesses that received the special COVID-19 funding have been processed, and the program is wrapping up very successfully. Recipient businesses were extremely grateful for this vital financial support to their businesses as they expended all efforts to mitigate the harm created for them by the pandemic.

## 4. Summer Company Student Entrepreneur Program Open for 2021

The first two applications from students have been received and our promotional campaign is beginning to roll out via social media with

excellent assistance from County secondary school teachers. Participants receive business planning and operational training from ERC staff, guidance from local insurance, accounting and legal professionals and business mentoring and coaching from successful business owners and operators. They also will receive a \$3,000 grant to develop and operate their business.

## 5. **Starter Company Plus**

Participants in our final intake for the 2020/21 fiscal year are nearing completion of their training. ERC staff are now focusing on assisting our clients with their business plan communications materials and their business pitch presentation. This is to prepare them for the Business Pitch Contest component of Starter Company Plus where those who wish may compete for a \$5,000 funding award. It is also important to prepare them for making their business case to financial institutions, funding agencies and potential business partners and investors.

## 6. Past Starter Company Plus Client Outstanding Success

Past Starter Company client, Valley Eats, is growing rapidly, and is now expanding service to Lanark County and beyond towards the Seaway Valley.

## 1. Forestry Activities

(a) Below is the Forestry Activity Tracker information for the month of January 2021:

- (b) The County Forester provided a forest health update at the Eastern Ontario Forest Health Network virtual Pest Review which is attached as Appendix FORGIS-I. It is expected that Gypsy Moth will continue to be a problem in 2021 in our area. A forecast prepared by the Ministry of Natural Resources and Forestry should be available soon.
- (c) Operations are continuing at Opeongo Tract, and operations has started at Byer's Creek Tract for the 2021 tender. There is additional revenue that will be applied to 2020 once the weigh slips up to December 31, 2020 are received for the Opeongo Tract. A small amount of area

remains to be harvested at Germanicus Tract and will be finished as soon as possible, pending equipment issues. This revenue will be applied to 2021.

## 1. Real Property – Projects Update

## 2. Service Delivery Improvement Project (SDIP)

Project Status as of February 1, 2021:

- (a) Front Reception Area waiting on glass for reception area before remaining work can be done. Glass tentatively scheduled to arrive by February 10.
- (b) Phase 1B Courtroom, Entrance and Waiting Area February completion date.
- (c) Phase 2 Boardrooms, Collaborative Area areas framed and dry walled.
- (d) Phase 3 Community Services and Paramedic Areas framed, dry walled and sanded, plumbing installed for new washrooms, flooring started.

#### 3. Natural Gas Procurement

**Recommendation:** THAT the Development and Property Committee recommend that County Council pass a By-law to execute an agreement with Local Authority Services (LAS) to participate in a Natural Gas Procurement Program.

## **Background**

The County of Renfrew has been part of the Natural Gas Procurement Program offered by LAS to Ontario Municipalities for more than twenty years along with over one hundred and sixty other municipalities, cities, towns and townships in the Province. The advantages of the program are:

- (a) Budget Stability;
- (b) Maximized Purchasing Power;
- (c) Periodic Program Rebates.

The annual consumption of Natural Gas at County facilities has averaged approximately 750,000 cubic metres for the past five years.

LAS was asked to provide a review of their program historical pricing compared with costing from the Natural Gas supplier Enbridge. The review summary indicated that over the past seven years the LAS program has been over \$60,000 higher or 6% annually. There are a number of factors that contribute to this:

- (a) The LAS program is designed to provide natural gas pricing stability and not necessarily to beat utility prices;
- (b) Abundance of gas availability compared to demand;
- (c) Milder winters;
- (d) Historically low natural gas prices.

The Real Property Assets Division is recommending renewal of the agreement with LAS. The renewal is for a two-year period after which the municipality can opt out of the program. The program can then be reviewed for effectiveness prior to the two-year expiry but guarantees stability for the period especially with the unknowns for the future of the natural gas industry with issues like the pandemic, future demands and government regulations.
