Councillor Emon re-entered the meeting at 3:24 p.m.

Mr. Davis advised that the overlap agreement with TransCanada Pipeline for the alternative route for the Algonquin Trail through Garrison Petawawa lands was signed in February.

It was noted that there is a new grant opportunity through the Community Building Fund that has been announced to support non-profit tourism, culture, sport and recreation organizations including retrofits and rehabilitation to meet COVID-19 public health protocol requirements and local community needs and staff will look into this funding opportunity. Any funding that is received would offset the use of future capital reserves.

AND FURTHER THAT staff be directed to continue to seek any grant opportunities, revenue streams and/or partnerships to offset funding requirements. CARRIED.

AND WHEREAS the Ministry of Municipal Affairs and Housing approved the update to the Official Plan for the County of Renfrew in March 2020;

AND WHEREAS County Council directed staff to seek an approach to make changes to the approved Official Plan of the County of Renfrew that were more reflective of local context;

AND WHEREAS County planning staff prepared a draft Official Plan Amendment (OPA) 31, for this purpose:

AND WHEREAS the Minister of Municipal Affairs and Housing has provided the County of Renfrew with delegated authority, as permitted for in the Planning Act;

AND WHEREAS the local municipalities were offered an opportunity for early consultation on a draft of OPA 31 in November 2020;

AND WHEREAS the Ministry's March 2020 approval of the County of Renfrew Official Plan contained an extensive mapping layer of Significant Wildlife Habitat (Deer Wintering Area) that was not part of the Council adopted update to the Official Plan and submitted to the Ministry;

AND WHEREAS the Ministry's March 2020 approval of the County of Renfrew Official Plan contained an increase in the lands designated Agriculture that were not part of the Council adopted update to the Official Plan and submitted to the Ministry;

AND WHEREAS County of Renfrew OPA 31 is reflective of local Renfrew County context, as provided for within the Provincial Policy Statement;

NOW THEREFORE BE IT RESOLVED that the Development and Property Committee recommend that County Council receive the attached March 16, 2021 draft OPA;

AND FURTHER THAT the Development and Property Committee recommends to County Council that staff be directed to revise OPA 31 to reflect the mapping for Natural Heritage Features and Agriculture as adopted by County Council and submitted to the Province of Ontario as OPA 25;

AND FURTHER THAT the draft OPA 31 as revised at the direction of County Council be circulated in accordance with the provisions of the Planning Act to local municipalities, prescribed agencies, including the Ministry of Municipal Affairs and Housing, and that a designated period of time for comments be set out;

AND FURTHER THAT upon completion of this circulation and a subsequent review by this Committee and County Council, an electronic statutory public meeting be held on a future date yet to be determined. CARRIED.
