#### Wednesday, March 17, 2021

A virtual meeting of the Health Committee was held on Wednesday, March 17, 2021, at 9:30 a.m.

Chair Donohue called the meeting to order at 9:30 a.m. The roll was called, and no pecuniary interests were disclosed.

## Delegation

Mrs. Shelley Sheedy, Director of Long-Term Care, and Mrs. Jennifer White, Director of Care, Miramichi Lodge, presented "Miramichi Lodge Outbreak Update". Mrs. Sheedy overviewed the steps being taken to ensure resident and staff safety as well as a chronology of events related to the current outbreak at the home. Mrs. White overviewed the Miramichi Lodge COVID Care Unit.

Mrs. Sheedy and Mrs. White were thanked for the informative and reassuring COVID-19 update and were asked to pass thanks on to staff. They were further requested to provide the presentation at County Council. As well, a link would be sent to all local councils to view the presentation.

### **Emergency Services Report**

Chief Michael Nolan overviewed the Emergency Services Department Report and Addendum, is attached as Appendix A and B.

Chief Nolan overviewed the vaccine roll out process underway and stated that the Service is working with researchers from York University to develop a drive-through simulator for delivery of vaccine. The County of Renfrew is the first Service in the Country to employ this method. The drive-through centre is a sustainable solution from a staffing perspective and minimizes both public and staff exposure. Chief Nolan noted the province has been providing vaccine for two-weeks at a time, but not advising in advance which vaccine will be sent, how much will be forthcoming, and who will be receiving it. As well, each vaccine has a different requirement for storage and transportation, so the necessary logistics remain difficult to anticipate. The provincial registration number was launched on Monday but calls to this site are being redirected to local numbers.

### **Administration Report**

Mr. Paul V. Moreau overviewed the Administration Report which is attached as Appendix D.

Mr. Moreau reported that he received notification from Mrs. Shelley Sheedy of her intent to retire from her position as Director of Long-Term Care effective December 31, 2021, however her last day of work will be sometime in June. Mrs. Sheedy was congratulated for her exceptional accomplishments and contributions to both the long-term community and the County of Renfrew.

Mr. Moreau advised that the Ministry of Municipal Affairs and Housing has approved Upper Ottawa Valley, Highway 60, and North Renfrew together to move to a full application for a single integrated OHT. An application update to the Network 24 Partners and Supporters providing a proposed structure to complete the OHT application and next steps for all groups has been submitted.

The Eastern Ontario Wardens' Caucus has identified health care and health care transformation, including advocacy for virtual health care as priorities for 2021/2022. There will be one regional voice and will include municipal representation in governance.
