# **Long-Term Care Report**

Mrs. Shelley Sheedy introduced Mr. Mike Blackmore the new Director of Long-Term Care for Bonnechere Manor and Miramichi Lodge and Mrs. Kim Saunders the new Administrator at Bonnechere Manor.

### **RESOLUTION NO. H-C-21-06-66**
