# 5. Consolidated Homelessness Prevention Initiative (CHPI) 2021 Fourth Quarter (October 1, 2021 – December 31, 2021) Update [Strategic Plan Goals #1, #2 & #3]

Originally implemented in January 2013, the Community Homelessness Prevention Initiative (CHPI) is a 100 per cent provincially funded outcomesbased program that aims to prevent and end homelessness by improving access to adequate, suitable, and affordable housing and homelessness services for people experiencing homelessness and for people at-risk of homelessness.

The County of Renfrew's CHPI allocation for 2021-2022 is \$1,447,608. This funding is used to deliver local programs that help with housing security: Homelessness Prevention Program (HPP), Rent Allowance, and Emergency Minor Home Repairs.

#### **Homelessness Prevention Program (HPP)**

This is an emergency program that helps people to keep their current housing or secure new housing. Details about approved expenses and eligibility requirements can be found on the County's website on the Homelessness Prevention Program webpage.

#### **Rent Allowance**

The CHPI Rental Allowance Program is a monthly supplement paid to the landlord on behalf of a household in need of rental assistance; \$275/month for single people or couples with no dependents or \$375/month for families or sole support parents with children. This supplement is meant to bridge the gap between affordable rent and the actual market rent charged by the landlord. Households can remain eligible for up to three years and eligibility is verified annually.

### 1. RFP-DP-2022-01 Design Build of Multi – Residential Update [Strategic Plan Goal #2]

A mandatory site meeting for the new Multi-Residential Housing Project was held January 25, 2022 at the site located at Lea Street and Douglas Street. There were six contractors that attended, Becc Construction, Buttcon East Limited, Quasar Consulting Group, Rossman Architecture, R.G.T. Clouthier Construction Ltd. and William Sons. The details for the Request for Proposal (RFP) were reviewed and opportunity given for preliminary questions and site inspection. The deadline for formal questions to the RFP is February 18, 2022, and the closing date is February 25, 2022.
