Administration Department Report

Corporate Services Department Report

Mr. Foss overviewed the Corporate Services Department Report which is attached as Appendix B.

Mr. Foss overviewed the Memorandum of Understanding with Arnprior Regional Health that transferred the responsibility of the Renfrew County Virtual Triage and Assessment Centre (RC VTAC) to the County of Renfrew until March 31, 2022.

Warden Robinson advised that she was very pleased to announce at yesterday's Health Committee meeting, that after a lot of hard work and lobbying of Council and staff, and after a meeting held last week with Minister Elliott, we received the positive news that additional funding has been secured for RC VTAC until March 31, 2023. Warden Robinson thanked MPP John Yakabuski, who worked alongside County of Renfrew representatives in our lobbying efforts to get this issue in front of Minister Elliott.

Committee discussed the Public Health delegation at ROMA with the Honourable Christine Elliott, Minister of Health where concerns were expressed regarding the impact any future increases to the provincial/municipal cost-sharing model will have on the municipal tax burden. Warden Robinson noted that mitigation funding in 2021 helped with this shortfall, but the County of Renfrew will continue to advocate along with the Eastern Ontario Wardens' Caucus.

Mr. Foss overviewed the changes to Policy GA-01 Procurement of Goods and Services, specifically related to electronic bidding noting the difficulties during this pandemic in dealing with various tenders, without the use of an electronic bidding platform. Since this policy hasn't been updated since 2015, staff also had a significant number of housekeeping items, additions, deletions and clarity corrections to be made therefore, reached out to a solicitor for additional review.

- b) Removal of the Clerk/Cashier (Disclosure), Courtroom Clerk/Monitor and General Clerk/Cashier from Schedule "A" at Group 3 in the salary grid, removal of the Collections Clerk from Schedule "A" at Group 4 in the salary grid and addition of Court Service Specialist in Schedule "A" at Group 3 in the salary grid;
- c) Removal of the Asset Management Coordinator from Schedule "A" at Group 7 in the salary grid; and
- d) Change to the Student Wage from \$13.40 to \$14.10 (for students under 18) and from \$14.25 to \$15.00 (for students 18 and over) as outlined in Schedule "B".

AND FURTHER THAT the revised Employment By-law # 1 be adopted. CARRIED.
