Kayla Menkhorst, Executive Director of the Eganville and District Seniors, provided an overview of the initiatives being implemented through the Government of Canada's Age Well at Home Initiative grant funding that was received in the amount of \$799,896, with funds to be utilized over the next two years. She noted that the funding will allow partnerships between Eganville and District Seniors, Whitewater Seniors, Barry's Bay Area Home Support and the Algonquins of Pikwakanagan First Nation to expand the existing and successful, primarily volunteer-led programs for rural and remote seniors. Essential programs such as Meals on Wheels, Transportation, Home Maintenance, Frozen Meals, Home Support and Friendly Phone Assurance are a few of the examples of programs that will reach more seniors thanks to this funding opportunity.

**INFORMATION**

**1. Substance Use-Related Harms Dashboard**

Renfrew County and District Health Unit (RCDHU) has developed an interactive dashboard called Substance Use-Related Harms in Renfrew County and District (RCD). The purpose of this dashboard is to provide individuals and community partners with an overview of current substance use-related trends in RCD such as:

- Opioid overdose-related emergency department (ED) visits to local hospitals
- Opioid-related deaths
- Suspect drug poisoning deaths

The dashboard can be found on the [RCDHU website](#) within the new [Health Statistics](#) section.

This dashboard will be updated quarterly or as data becomes available. Data from recent years is considered preliminary and subject to change in future updates. Data is primarily sourced from the Office of the Chief Coroner of Ontario and the National Ambulatory Care Reporting System (NARCS) via the Ministry of Health.

**2. Mesa Coordinator**

We are very pleased to welcome Barb Tierney to the Mesa Coordinator position. Ms. Tierney will be working to support and align activities within the Community Services, Emergency Services, and Development and Property Departments and community partners. Since commencing her position on May 27, 2024, Ms. Tierney has been meeting with community partners, familiarizing herself with programs and services, and identifying priorities to help map out the pathway for enhanced community well-being.

**3. National Housing Strategy Funding Update**

Attached as Appendix I is a memo dated May 30, 2024, from Ms. Angela Cooke, Assistant Deputy Minister for the Ministry of Municipal Affairs and Housing, providing an update on the National Housing Strategy (NHS) funding. On May 28, 2024, Federal and Provincial Ministers responsible for housing announced a joint agreement unlocking

\$357 million in federal funding under the National Housing Strategy. Consequently, all NHS programs for the fiscal year 2024-25, including the Canada-Ontario Community Housing Initiative (COCHI), Ontario Priority Housing Initiative (OPHI), and Canada-Ontario Housing Benefit (COHB), will proceed. The memo indicates that funding allocations for COCHI and OPHI will be confirmed shortly, with COHB details to follow. As part of the revised NHS Action Plan, Ontario will initiate the following new steps:

- Establish provincial supply targets with Service Managers and Indigenous Program Administrators;
- Direct funding toward new projects;
- Set annual goals; and
- Implement robust data collection and reporting mechanisms.

Further details will be shared in the coming months as the Ministry collaborates with Service Managers and Indigenous Program Administrators to enhance affordable housing initiatives to support vulnerable community members.

#### **4. Community Services Staff Day**

The annual Community Services Staff Day will be held on June 13, 2024, at Sand Point Golf Course in Braeside. Staff will receive training on early childhood trauma and its impacts across the lifespan. The facilitator, Mary Hewitt, holds a master's degree in Early Childhood Education, two bachelor degrees one in Psychology and one in Education, and an Early Childhood Education diploma. She is passionate about mental health, early learning and care. Attached as Appendix II is a poster providing details regarding the workshop, titled "From Hurting to Healing," which will explore the nature of trauma and the impact of compassionate, informed care on practice.

#### **5. Pembroke and Area Warming Centre Committee**

The Pembroke and Area Warming Centre Committee held its final meeting on June 5, 2024 marking the conclusion of its collaborative efforts. The Committee was established to ensure broad representation and input from a diverse range of organizations regarding the centre's operations. The Warming Centre, which was open from December 1, 2023 to April 18, 2024, was funded through contributions from four municipal partners and fundraising efforts led by The Grind Pembroke. With the centre now closed, the Committee has been dissolved, and a final report on its activities and future recommendations will be prepared and brought to Committee at the next meeting.

Dear Service Manager/Indigenous Program Administrator,

I am pleased to take this opportunity to inform you that the Federal and the Provincial Ministers responsible for housing released a joint statement on May 28, 2024 ([Joint-Statement](#)) that an agreement has been reached on a revised action plan from Ontario that will unlock \$357 million of federal funding under the National Housing Strategy (NHS).

Based on this, we will be proceeding to implement all the National Housing Strategy (NHS) programs (Canada-Ontario Community Housing Initiative (COCHI), Ontario Priority Housing Initiative (OPHI) and Canada-Ontario Housing Benefit (COHB)) for this fiscal year.

As such, the 2024-25 funding allocations for COCHI and OPHI for your area will be confirmed through a separate letter from Minister Paul Calandra shortly. Details on COHB allocations to enroll new participants in the program for 2024-25 will be provided to all Service Managers at a later date.

Through this communication, I would also like to highlight that Ontario will initiate the following new steps as per the revised NHS Action Plan submitted to the Federal government:

- Establish provincial supply targets with service managers and Indigenous program administrators.
- Direct funding toward new projects.
- Set annual goals; and
- Implement robust data collection and reporting mechanisms.

We will be sharing more details on these measures in the coming months and engaging with Service Managers and Indigenous Program Administrators as we continue to work together to implement these important affordable housing initiatives to assist vulnerable Ontarians across all communities.

### **INFORMATION**

#### **1. Ottawa Valley Ontario Health Team (OVOHT) Mental Health, Addictions and Substance Use Health Network**

The Community Services Department has recently been invited to participate in the Ottawa Valley Ontario Health Team (OVOHT) Mental Health, Addictions and Substance Use Health Network. This group meets monthly to discuss issues and strategies related to health supports in mental health and substance use. We are pleased to hold a seat within this network and look forward to the continued collaboration.

#### **2. Renfrew County Youth Wellness Hub Ontario – Renfrew Site Grand Opening**

On May 3, 2024, the Youth Wellness Hub Ontario (YWHO) officially opened a second location at the myFM Centre in Renfrew. YWHO is a program for young people aged 12 to 25 years of age delivered by Addiction Treatment Services through the Renfrew Victoria Hospital. YWHO provides free mental health and substance use services as well as a wide range of activities in a safe and inclusive space. Community Services staff attend both the Pembroke and Renfrew YWHO locations regularly to connect youth with programs and services offered through our Department. Appendix OW-I is a copy of the YWHO summer newsletter providing further information about their programs. Community Services staff were pleased to attend the grand opening event to support the expansion of services to youth in Renfrew County.

#### **3. Mesa Gathering**

On May 22, 2024, the County of Renfrew in partnership with the Renfrew County and District Health Unit hosted the Mesa Gathering which took place at the Miramichi Lodge in Pembroke. This event served as the official launch of our Mesa initiative and brought together over 30 local service providers working in the areas of mental health, substance use and homelessness. The event was a great success and included presentations from keynote speakers as well as presentations on the lived experience of two local residents. The day ended with a world café engagement exercise from which the County will analyse and share the feedback with partners in attendance while also forming recommendations based on the collected information.

#### 4. Community Services Outreach Initiatives

In an effort to ensure that services are available to residents within the community and to reduce barriers in accessing these supports, our staff have been working in close partnership with numerous agencies across the County. Staff are onsite at various locations providing person-centred supports. Staff are working closely with those experiencing housing and food insecurity by attending The Grind in Pembroke and the Renfrew and Area Connection Centre, located in Renfrew, on a weekly basis. Staff are also attending local Employment Ontario locations across the County, supporting residents who are accessing both financial and employment supports. Staff are onsite monthly at both Youth Wellness Hub locations to ensure information and resources about community services programming is provided to those who need it. Over the last three months, staff have also participated in evening resource clinics, an initiative launched by ConnectWell Community Health, to provide drop-in clinics during non-business hours in Beachburg, Cobden, and Eganville. We are grateful for the established relationships with our community partners and continue to look for ways to reduce service barriers for residents.

#### DELEGATION AUTHORITY APPROVALS

5. The following item was approved under By-law 98-24:

Section 5.0 - Agreements – Funding, Subsection 5.1 - Built for Zero Canada – Memorandum of Understanding Extension – Extending the County of Renfrew’s agreement until March 31, 2025 – Memorandum of Understanding, attached as Appendix OW-II, has been signed by the Director of Community Services. The original agreement was approved by Committee Resolution Number CS-C-22-04-27 on April 13, 2022 for a two-year term from April 1, 2022 to March 31, 2024.

##### **Background**

The County of Renfrew signed a Memorandum of Understanding (MOU) with Built for Zero (BFZ) Canada in April 2022. BFZ is a national change effort to help communities reduce the level of chronic homelessness to a functional zero. BFZ provides valuable guidance and support to our staff and community partners around quality data collection and rapid service pathways to support individuals experiencing housing insecurity and homelessness. 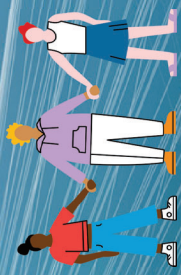

**BACKGROUND**

Whereas the Community entered into an Agreement with CAEH effective April 1, 2022, that has a term of April 1, 2022, to March 31, 2024 (“Agreement”).

Whereas CAEH desires to amend the Agreement to extend the current term and confirm the Community’s cohort(s) and Project Officers.

**NOW THEREFORE THE COMMUNITY AND CAEH AGREE AS FOLLOWS:**
